The representations provided in this application are complete and accurate. I understand the information provided will be relied upon in the evaluation and extension of credit terms. I authorize the release of information by creditors listed above as well as other suppliers. The terms and conditions of this application shall, upon extension of credit by Portland Fasteners constitute an agreement of sale. Applicant certifies that this extension of credit is for business purposes only, not for household, family, or personal use. The applicant agrees to be bound to the terms and conditions stated in this application. The payment for all sales of goods or services will be according to the terms stated on Portland Fasteners invoice. The failure to pay on the due date of each invoice shall deem the debt to be delinquent. In the event of a delinquency, Portland Fasteners may impose a finance charge of the lower of (a) one and one half percent per month or (b) the highest rate permitted by law on the delinquent balance until paid. In the event of a delinquency, Portland Fasteners may recoup any discounts to be applied to the applicant's debt. In the event of a delinquency, all collection expenses, court costs, and attorney's fees in connection with the collection of the delinquent debt shall be due and payable by the applicant. I agree that this agreement will be governed by Oregon law, and consent to the jurisdiction of the state and federal courts located in Multnomah County, Oregon if any suit or action is filed in connection with this agreement.
